# CHILD CARE SUBSIDY - CCS

ASSISTANCE TO HELP YOU WITH THE COST OF CHILD CARE

## TO GET CCS YOU MUST

Care for a child 13 or younger who is not attending high school, unless an exemption applies.

Use an approved child care service.

Be responsible for paying the child care fees.

Meet residency and immunisation requirements.

## HOW MUCH YOU CAN GET

The amount of child care subsidy you can get depends on your circumstances.

Your income affects it - the subsidy percentage you're entitled to depends on your family's income.

The type of child care affects it - the amount of subsidy you can get depends on the type of approved child care you use, as well as the age of your child.

Your activity level affects it - the hours of subsidised care you can get per fortnight depends on the hours of recognised activities you do.

The amount of subsidised child care you can access per fortnight applies to each child.

## ENROLMENTS & BOOKINGS

Please ensure the parent identified as the 'enrolling parent' is the person who holds the CRN, or is applying for a CRN, and is the parent 'linked' to the child by Centrelink who has completed the application for the CCS. The DOB of this enrolling parent is mandatory.

**It is these details that will release your childcare data to Centrelink.**

## BILLING INFORMATION

**Please notify us if you prefer another email address for invoices.**

**One invoice will be issued for each week, with the dates for the period covered appearing on the invoice. Please check the sessions invoiced and notify us immediately if there appears to be any problems.**

**Any government payments will be shown under "subsidies"**

**Terms of payment are shown on receipt of invoice.**
